


### WRITER WITH ALBANY TIES, JOSLYN GAINES VANDERPOOL, PINS THIRD BOOK

Although Joslyn Gaines Vanderpool lived only briefly in Albany with her parents, Morris and Ruth Gaines, she is nostalgic about those times as well as her trips from Sacramento, California each year by car to visit her grandparents and other relatives here. She recalls that because of her race, her parents, sister Francene Gaines Weatherspoon and herself couldn't stay in hotels or eat in many southern restaurants. They made do by sleeping in the car on the side of the road and picnicking. Her parents entertained



them with games and songs. Her father would tip gas station attendants willing to get them ice cream cones. By dining outdoors, they thought that they were camping. At night, they parked along forested Kenyatta's Stone areas. Her mom treated her and her sister like princesses, rolling their hair and putting scented powder on them. They washed in bathroom rest stops when available and changed into pajamas behind moss-covered tree near bayous. Bathroom breaks were in the bushes. Upon arrival in Albany, evenings were spent on her grandma's porch making peach ice cream. Sundays were spent in Beulah Baptist Church where her parents served until their deaths. Her great great parents were ex-slaves, Warren and Elviry Gaines.

All of my guys have been working diligently to become qualified."

USS FORD sailors have been working to become qualified while running WSWE-1 which was accepted and turned over to the ship's force on December 21, 2018. and USWE-3 which was accepted and turned over on February 14, 2019. "WSWE-3 was turned over on my birthday," said James. This was a sense of accomplishment among us all and a great birthday present for me."

Daily operations of the AWEs allow Sailors to grow confidence in their proficiency with the systems and their operating capabilities. Their trial-and-error expertise not only helps them better anticipate and diagnose any technical issues that may arise, but also grants them the ability to create training methods and pave the way for how future USS FORD-class Sailors learn to operate AWE's.

In an effort to bring community awareness to mental health and suicide prevention the Albany State University Office of Counseling and Accessibility Services participated in the Active Minds' Send Silence Packing exhibit on Wednesday, March 16.

### DUKES LEGISLATIVE AND COMMUNITY REPORT

Rep. Winfred Dukes (D-Albany) has introduced House Resolution 1000 Creating the Joint Study Committee for Promotion and Assistance of Small Farmers.

Co-sponsors of the resolution include Rep. Regina Lewis-Ward (D-Mc-Donough, Rep. Mandisha Thomas (D-South Ful-

ton), Rep. El-Mahdi Holly (D-Stockbridge), and Rep. Josh McLaurin (D-Sandy Springs).

The protection and support of small farmers is imperative. We will lead in the diversification of crop production that can make individual farms stronger and strengthen agricultural industries in Georgia. Tapping into profitable niche markets can reduce economic risk by growing more than one type of crop on farmland. The local production of goods strengthens the economy. Research shows that growing a variety of crops can improve the sustainability and resiliency of agricultural systems and producing different crops on small farms greatly benefits farmers.

According to the UGA Center for Agribusiness & Economic Development, Agriculture contributes approximately \$73.3 billion annually to Georgia's economy. One in seven Georgians works in agriculture, forestry, or related fields.

In 2012, there were 42,257 farms in Georgia encompassing 9,620,836 acres of land, 88 percent of which are considered to be small businesses in terms of annual sales. The number of small and medium sized farms has and continues to decline in Georgia and across the country, as a result of multiple pressure points which disproportionately affect these farmers, despite their importance to the health of the Georgia economy.

Our goal is to create good paying jobs with benefits and profitable farms throughout the state. Fight for diversifying markets and growing a healthy agribusiness sector, strive for sustainable agriculture, and provide access to healthy, locally grown food.

"We don't only rely on the PQS system, we get hands-on," said James. All of us work with NNS to do familiarization operations to learn the fundamentals routinely. Our crew has even begun to write Navy Enlisted Classification qualifications standard for the future AWE-C school.

"My crew has given me the utmost confidence in our abilities," said James. "I try to lead by example, but we have all claimed ownership in our elevators. We take our job personally and we continue to improve because we are the first with this knowledge. This is our thing. This is our baby." The GERALD R. FORD is a first-in-class aircraft carrier and the first new aircraft carrier designed in more than 40 years. FORD is currently undergoing its post-shakedown availability at Huntington Ingalls Industries-Newport News Shipbuilding.







### VOTING LEGISLATION CLEARS HOUSE

House Bill 1464 passed the House by a vote of 98-73. It combines text and policy from a number of different election bills, along with adjustments to procedures established in SB 202, to create an omnibus election bill for 2022.

A few of the bill's provisions bolster accessibility. One allows voters to take two hours off of work during the period of advanced voting to cast their ballot, in addition to election day. Another provision eliminates the requirement that counties publish the number of ballots cast on election day by 10pm that night. But overall, opponents say the bad outweighs the good in this legislation and takes Georgia steps back instead of forward in voting rights.

The bill creates original jurisdiction in the Georgia Bureau of Investigation (GBI) to investigate any alleged violation of the election code.

HB 1464 creates further limits on the ability of outside groups to donate to county election administration efforts. Rather than leaving open the opportunity to donate to county commissions, the bill requires any donation, from a local in-kind donation to a large monetary grant, to go through an application process with the State Election Board (SEB).

The bill allows the SEB to appoint members of county election boards as members of a performance review board. Another such provision allows counties to allocate voting machines per 250 voters remaining who have not yet voted, as opposed to requiring one machine per active voter.

A third measure clarifies mailing absentee ballot applications and the disclosure required on them and confirms that parties may make absentee ballot applications available upon request. A provision eliminates the requirements that counties send out emergency write-in ballots to voters who qualify under the federal Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA).

The bill incorporates most of the requirements of HB 1359, creating enormous administrative burdens as well as unfunded costs on counties due to "chain of custody" requirements for blank security paper and absentee ballots. The provisions of HB 933 were also added to this bill. These provisions would eliminate the requirement that all election records that are transferred to their local clerk of superior court be sealed, effectively making these documents open records that are subject to public inspection once they are transferred. Voted ballots are only transferred to the custody of the superior court once the election has been certified. Source: https://www.legis.ga.gov

Garvey was charged by the U.S. government with mail fraud and convicted. In 1925, he was incarcerated in an Atlanta federal prison. Two years later he was paroled and deported to Jamaica, where huge crowds welcomed him. Persecution by the United States had made him an international hero.

Garvey turned toward a philosophy of racial purity in the mid-1920, leading to collusion with the KKK to organize a black separatist state.

In 1928, Garvey released a "Petition of the Negro Race" to the League of Nations; it was ignored. In 1935, Garvey left Jamaica for London, never to return. He died June 10, 1940.





### LEGISLATIVE UPDATE

The Senate voted 31-21 to back legislation that would impose harsher penalties for crimes committed during a protest. This includes blocking a highway, assaulting someone or damaging property if it involves groups of two or more people. It also calls for punishing local governments that instruct public safety officers to "stand down" during protests.

The Senate unanimously passed Senate Bill 609, that would set a May 31 deadline for the Georgia Access to Medical Cannabis Commission to issue licenses.

The Senate Finance Committee supported suspending Georgia's 29.1-cents-per-gallon gas tax through May 31, which would save drivers about \$400 million in taxes. The effort to remove the gas tax comes as pump prices rapidly rising.

Senate Resolution 623 would ask voters in November (constitutional amendment) if state senators should serve four-year terms starting in 2024. They currently serve two-year terms as do members of the state House of Representatives. The measure passed 49-3. The legislation was fast-tracked after first being introduced March 4.

The House voted 136-33 for House Resolution 842, which would put a proposed constitutional amendment on the ballot in November to take the issue of legislator pay out of the General Assembly's hands. If approved, legislators would be paid 60% of the median household income of Georgians, starting in 2025.That would almost double lawmakers' current pay of \$17,342. Lawmakers last received a cost-of-living raise in 2008. The House also voted 151-17 to increase the pensions of part-time lawmakers up to 38% and quadruple what House Speaker David Ralston could receive. Both measures now head to the Senate for its consideration.

House Bill 1184 seeks to make college more accessible to more students by allowing schools to administer college entrance exams like the SAT and ACT. Currently these exams are typically off campus. Having the exams where students already are will increase access.

HB 1283 provides that each elementary school shall schedule recess for all students in kindergarten and grades one through five (with certain practical exceptions). Schools are also not allowed to prohibit students in kindergarten and grades one through five as a disciplinary repercussion.

HB 1515 allows institutions previously accredited by the Southern Association of Colleges and Schools that are now accredited by the Transnational Association of Christian Colleges and Schools to be considered an approved school for the Tuition Equalization grant. This bill only impacts Morris Brown College and Paine Colleges (both HBCUs); this would allow students at these schools to receive HOPE funding.

health care providers. The council members will also make recommendations to the Newborn Screening and Genetics Advisory Committee for rare diseases. The advisory council can solicit and accept donations, gifts, grants, property, or matching funds from both public and private sources. The council will publish annual reports to the governor and the general assembly that will include both progress and funding reports, with the first such report due no later than June 20, 2023.

HB 937 requires insurers providing individual accident and sickness insurance coverage for mammograms and Pap smears to provide insured females ages 40 and older with written notice of coverage for annual mammograms, as medically advised. Early detection is crucial to fighting breast cancer.

HB 1390 creates a legal cause of action for retaliation against a county, municipal, or consolidated government if that government takes any adverse action against the individual's professional work relationship based on that individuals' rejection of any sexual harassment, report of it, institution of any investigation, or testimony related to sexual harassment.

HB 1425 attempts to provide faster relief to families awaiting access to low-THC cannabis. Legislation in 2020 created a process whereby companies could be licensed to produce low-THC cannabis in Georgia, but the process to licensure to date has been inefficient and isn't providing the relief Georgia families need. This legislation would allow the State to begin providing product to families while restarting the licensing procedure through a process conducted by the Department of Administrative Services under normal state purchasing laws and allow the retention of a qualified independent third party to help develop the solicitation materials and review applications.

HB 1421 revises the Georgia code relating to hazardous waste to allow for certain hazardous waste fees to be dedicated to the Hazardous Waste Trust Fund, until that fund reaches a total of \$25 million. The Hazardous Waste Trust Fund is supported by monies collected from hazardous waste generators, solid waste tipping fees, and various fines for violations. The Fund, which is administered by the Georgia Environmental Protection Division, is used to remediate contaminated sites throughout the state. If the collection of fees were to sunset, the ability of local governments to fund the clean-up of leaking landfills, as well as abandoned and




